Federal multi-candidate political action committees (PACs) may contribute \$5,000 per election. Contributions from corporations, labor organization treasury funds, foreign nationals, and federal government contractors are prohibited. Corporations and individuals are strictly prohibited from reimbursing another person for making a contribution to Friends of Hillary.
